**ORDINANCE NO. 247**

**AN ORDINANCE OF RIEGELSVILLE BOROUGH, BUCKS COUNTY, PENNSYLVANIA ENACTING AND LEVYING CERTAIN TAX RATE ON ALL REAL PROPERTY WITHIN THE BOROUGH**

Under and pursuant to 8 Pa. C.S.A. § 1302, the Council of the Borough of Riegelsville hereby **ENACTS** and **ORDAINS** a tax and the same is hereby levied on all real property within the said Borough subject to taxation for the fiscal year 2023 as follows:

Tax rate for general purposes, the sum of.....13.00 mils  
on each dollar of assessed valuation, or sum of.....\$ 1.30  
on each one hundred dollars of assessed valuation

For fire protection purchases, including fire apparatus  
The sum of..... 3.00 mils  
on each dollar of assessed valuation, or sum of..... \$.30  
on each one hundred dollars of assessed valuation

For Ambulance & Rescue Squad purposes, the sum of. .500 mil  
on each dollar of assessed valuation, or sum of..... \$.05  
on each one hundred dollars of assessed valuation.
